ABBA HOUSE

ABBA HOUSE WAS DWC'S FIRST PROGRAM AND IT OPENED WITH THE DIRECTION OF SISTER MARY VIRGINIA CLARK IN 1989. ABBA HOUSE IS A LARGE TWO STORY BUILDING THAT ACCOMMODATED 10 PRIVATE EFFICIENCY APARTMENTS WHERE WOMEN IN RECECOVERY FROM ADDICTIONS AND THEIR CHILDREN MAY LIVE UP TO 2 YEARS. DWC SERVED 33 WOMEN AND CHILDREN DURING 2009-2010. THESE OWMEN USUALLY HAVE 6 MONTHS SOBRIETY BEFORE ENTERING ABBA HOUSE FROM OUR OTHER SHELTER, HAVEN HOUSE. OF THE WOMEN COMPLETING OUR PROGRAM AND GRADUATING, 845 ARE STILL CLEAN AND SOBER 5 YEARS LATER. WE GRADUATED 7 WOMEN IN MARCH 2010. FUNDING FOR THIS PROGRAM CAME FROM SPEICAL EVENTS, GRANTS, AND SALES FROM OUR RETAIL STORES.

TRANSITIONAL HOUSING

TRANSITIONAL HOUSING WAS STARTED AT DWC IN MARCH 2004. DWC CONTRACTED WITH THE CITY OF AMARILLO TO PROVIDE THE INTENSIVE CASE MANAGEMENT AND SUPPORTIVE SERVICES FOR 127 INDIVIDUALS INCLUDING 85 CHILDREN AND THE CITY PROVIDED THE SUBSIDIZED RENTAL ASSISTANCE. TRANSITIONAL HOUSING IS PARTIALLY FUNDED BY A CONTINUUM OF CARE SUPER NOFA FEDERAL GRANT AND DWC PROVIDED THE REMAINING FUNDING GHROUGH SPECIAL EVENTS, GRANTS, AND SALES FROM OUR RETAIL STORES. THIS IS A TWO YEAR PROGRAM WITH FAMILIES LIVING IN HOUSING LOCATED THROUGHOUT AMARILLO. GRADUATES QUALIFY FOR SECTION 8 (HUD) HOUSING UPON GRADUATION. MANY OF THE WOMEN THAT GRADUATE THE DWC RECOVERY PROGRAM

HAVEN HOUSE PROGRAM WAS STARTED IN APRIL 2007 AFTER THE 30 YEAR OLD WOMEN'S ALCOHOL AND DRUG RECOVERY CENTER DONATED THE FACILITY AT 1308 S BUCHANAN TO DWC. HAVEN HOUSE IS THE ENTRY LEVEL FOR THE DWC RECOVERY PROGRAM WITH BEDS FOR 17 WOMEN USUALLY NEW IN THEIR SUBSTANCE ABUSE RECOVERY. MANY OF THESE WOMEN CAME TO DWC FROM THE STREETS WITH SOME ONLY HAVING 24 HOURS SOBRIETY. MOST HAVE LOST EVERYTHING INCLUDING THEIR CHILDREN BY THE TIME THEY GET TO HAVEN HOUSE. THIS FACILITY HAS FOUR LARGE DORMS WITH 4 WOMEN LIVING IN 3 OF THE DORMS AND 5 WOMEN LIVING IN THE LARGEST DORM. CHILDREN ARE NOT ABLE TO
